LOCATION



How important is a location close to the family for your loved one? Will you be visiting several times a week, on weekends or periodically as time allows? Are your parents still active and social, and eager to participate in activities with other residents or at a senior community center?

Your conversations together about these issues will help you find the best location for their needs first, not yours. There may be an ideal residential community for their needs and activities they're interested in, but a bit further away from you than ideal; however, if your parents are independent and able to integrate into social settings with enthusiasm, the better choice is one in which their primary needs and activities are best met. Who knows - - they may be so busy, they won't have so much free time to visit? On the other hand, if your mom or dad is shy, introverted or enjoys individual activities better, as well as depends on regular visits from you and your family, it will be very important to choose a convenient location that can meet the important factors in their residential needs as well as allow frequent visits together.

Depending on your proximity to any metropolitan area of a minimum size of approximately 15,000 people and with a hospital within close proximity, there will almost without fail

be a Convalescent/ Skilled Nursing Facility and Assisted Living Communities. The latter are developing at a phenomenal pace, even with the housing crisis. If location is important so that family members can visit with regularity and convenience, there is usually some viable option to accommodate no matter where your loved one lives.

The most important thing is open discussion and planning in advance of long-term residential care needs. If your parents are still alert and able to make decisions, involve them directly in this process. Their input is critical for the best choice to be possible and to ensure their cooperation and enthusiasm.

Resources for Caregivers and Seniors

Did you know that many metropolitan areas offer opportunities for seniors to enter or return to the job market? Through Federal Title V legislation, municipal agencies provide part-time on-the-job training for seniors. Through partnerships with non-profit community organizations, the Senior Community Service Employment Program (SCSEP) provides training to prepare participants for employment in a variety of industries, including finance and business services, health care, tourism, electronics manufacturing and retail distribution. The seniors earn a subsidized wage, as they work toward unsubsidized employment. Qualifications for the program include:

- Age 55 or older
- Resident of the City of LA (for example)
- Within Federal low-income guidelines
- Unemployed
